## A BILL

To award a Congressional Gold Medal, collectively, to the women in the United States who joined the workforce during World War II, providing the vehicles, weaponry, and ammunition to win the war, that were referred to as “Rosie the Riveter”, in recognition of their contributions to the United States and the inspiration they have provided to ensuing generations.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Rosie the Riveter Con-  
3 gressional Gold Medal Act of 2018”.

4 **SEC. 2. FINDINGS.**

5 Congress finds the following:

6 (1) Over 70 years ago there was a call to ac-  
7 tion, a demand for workers to fill the vacancies left  
8 by the men who went to fight in the war.

9 (2) Six million women answered the call then,  
10 entering the workforce during World War II and  
11 providing the weaponry and ammunition to end the  
12 war.

13 (3) These women left their homes to work or  
14 volunteer full-time in factories, farms, shipyards, air-  
15 plane factories, banks, and other institutions in sup-  
16 port of the military overseas.

17 (4) They worked with the United Service Orga-  
18 nizations and the American Red Cross, drove trucks,  
19 riveted airplane parts, collected critical materials,  
20 rolled bandages, and served on rationing boards.

21 (5) Our “Rosie the Riveter”, the women who  
22 worked and sacrificed to strengthen this country  
23 during World War II, are among the greatest living  
24 heroines in the United States.

25 (6) These women persevered, despite often fac-  
26 ing harassment from their male colleagues and dis-

1 approval from their male family members, and all  
2 the while continued to maintain their “other jobs”  
3 as caretakers of children and their households.

4 (7) Minority women also overcame long held  
5 policies of discrimination and made significant con-  
6 tributions to the war effort.

7 (8) Because of the “Rosies”, Federal, State,  
8 and local agencies coordinated with business owners  
9 to develop child care programs and other supports  
10 for working mothers.

11 (9) The example that these women set during  
12 World War II continues to inspire us and blaze a  
13 path for the working women of today.

14 (10) Specifically, the images of “Rosie the Riv-  
15 eter” and the phrase “We Can Do It” continue to  
16 symbolize the empowerment of women today, rep-  
17 resenting patriotic women who want to serve and  
18 strengthen their country.

19 **SEC. 3. DEFINITIONS.**

20 (a) **ROSIE THE RIVETER.**—The term “Rosie the Riv-  
21 eter” includes any female individual who held employment  
22 or volunteered in support of the war efforts during World  
23 War II.

24 (b) **SECRETARY.**—The term “Secretary” means the  
25 Secretary of the Treasury.

1 **SEC. 4. CONGRESSIONAL GOLD MEDAL.**

2 (a) AWARD AUTHORIZED.—The President pro tem-  
3 pore of the Senate and the Speaker of the House of Rep-  
4 resentatives shall make appropriate arrangements for the  
5 award, on behalf of Congress, of a single gold medal of  
6 appropriate design to Rosie the Riveter, collectively, in  
7 recognition of their contributions to the United States and  
8 the inspiration they have provided to ensuing generations.

9 (b) DESIGN AND STRIKING.—For the purpose of the  
10 award referred to in subsection (a), the Secretary shall  
11 strike the gold medal with suitable emblems, devices, and  
12 inscriptions, to be determined by the Secretary.

13 (c) NATIONAL MUSEUM OF AMERICAN HISTORY.—

14 (1) IN GENERAL.—Following the award of the  
15 gold medal in honor of Rosie the Riveter, the gold  
16 medal shall be given to the National Museum of  
17 American History of the Smithsonian Institution,  
18 where it will be available for display as appropriate  
19 and made available for research.

20 (2) SENSE OF CONGRESS.—It is the sense of  
21 Congress that the National Museum of American  
22 History should make the gold medal received under  
23 paragraph (1) available for display elsewhere, par-  
24 ticularly at other appropriate locations associated  
25 with Rosie the Riveter.

1 **SEC. 5. DUPLICATE MEDALS.**

2 (a) IN GENERAL.—Under such regulations as the  
3 Secretary may prescribe, the Secretary may strike and sell  
4 duplicates in bronze of the gold medal struck under sec-  
5 tion 4, at a price sufficient to cover the costs of the med-  
6 als, including labor, materials, dies, use of machinery, and  
7 overhead expenses.

8 (b) PROCEEDS.—Amounts received from the sale of  
9 the duplicates under subsection (a) shall be deposited in  
10 the United States Mint Public Enterprise Fund estab-  
11 lished under section 5136 of title 31, United States Code.

12 **SEC. 6. STATUS OF MEDALS.**

13 (a) NATIONAL MEDALS.—Medals struck under this  
14 Act are national medals for purposes of chapter 51 of title  
15 31, United States Code.

16 (b) NUMISMATIC ITEMS.—For purposes of section  
17 5134 of title 31, United States Code, all medals struck  
18 under this Act shall be considered to be numismatic items.
